In the second year of the funding cycle, no application is necessary as your allocation will typically be based on the first year allocation with adjustments made according to the fundraising campaign results. In the second year of funding, you will be asked to submit a report to monitor financial stewardship and to help us tell the story of your impact. HLUW will be accepting applications that align with our core community impact areas of: Health, Education and Financial Stability

Basic Eligibility Requirements

Agency location within the HLUW's Geographic Service Area:

- Ashland and Bayfield Counties of Wisconsin
- Greater Duluth Area of Minnesota (cities of Hermantown and Proctor)
- Lake and Cook Counties of Minnesota
- Superior-Douglas County of Wisconsin
- At least .5FTE paid staff located in HLUW's service area (as defined above)
- Inclusion of at least one Board member residing in HLUW's service area (as defined above)
- IRS tax-exempt designation of 501(c)(3)
- Agency mission is consistent with HLUW funding priority (Health, Education and Financial Stability)
